Definitions

Certificate Application: The CGA may issue a certificate, for a period of up to three years, to natural

persons or legal entities offering gaming-related services or goods to holders of a B2B or B2C license.

Categories of entities requiring certification will be issued separately by CGA in a Certification Policy.

Domain: The unique address used to identify a website on the internet. A policy regarding the

acceptability of Mirror Domains and applicable fees in this regard will be issued separately by the

CGA.

Gambling License: B2C Operating license

Listed UBO: a UBO which shares are publicly traded on an exchange.

Qualified Interest Holder: A natural person holding direct or indirect interest of at least ten percent

of the subscribed share capital, or a similar interest, or the ability to directly or indirectly exercise at

least ten percent of the voting rights, or similar control.

Supplier License: B2B platform/software license

UBO: A natural person who is the ultimate owner, or has ultimate control, of a legal entity, by directly

or indirectly holding more than ten percent of the shares, voting rights, or ownership interests in that

legal entity.

Annual Fees - B2C

First Invoice

Initial Annual Fees are calculated pro-rata for the year of issuance. These are required to be paid within 14 days of notification by the CGA to the local director of the company of the license grant.

Annual Fees

Annual Fees are for all subsequent years are payable in full by January 15th on receipt of invoices by the CGA.

There will be two invoices simultaneously issued. One for the Curacao government (National Treasury) (the License Fee) and one for the CGA (the Supervisory Fee) each payable in full electronically in accordance with banking instructions specified on <u>each</u> invoice.

All fees are non-refundable.

Annual Fee – B2B

First Invoice

Initial Annual Fees are calculated pro-rata for the year of issuance. These are required to be paid within 14 days of notification by the CGA to the local director of the company of the license grant.

Annual Fees

Annual Fees for all subsequent years are payable in full by January 15th on receipt of invoice by the CGA.

The fee is payable in full electronically in accordance with banking instructions specified on the invoice.

All fees are non-refundable.

Annual Fee Treatment- First Year post LOK enactment

For the first 12 months post LOK enactment (24th December 2024 to 24th December 2025), an approved applicant is formally granted a licence only after payment of the first invoice(s), which covers the initial six-month period (rather than the complete annual fee).

- For B2C licences, this includes amounts due to both the Curação Gaming Authority (CGA) and the Government of Curação (National Treasury).
- For B2B licences, this invoice includes only the amounts due to the CGA.

Before the expiry of the initial six-month period, licence holders whose licence is eligible for continuation/extension for a further 6 months, will receive a second invoice covering the subsequent six-month period, beginning immediately after the first. Please note that these six-month billing periods may cross calendar years during the first year of licensing.

After the first year, and once a full licence has been granted, the licence holder will transition to annual invoicing.

Please note that the issuance of an invoice alone does not constitute confirmation of a licence continuation or extension. Such confirmation is only valid when expressly communicated in writing by the CGA.

If a license is revoked, whether or not at the request of the license holder, the full fee for the period to which the payment relates remains payable. If, for example, the fee applies to a provisional license valid for six months, the fee for that six-month period remains payable regardless of when the license is revoked. If it applies to a one-year period, the full amount for that year remains payable regardless of when the license is revoked during that period.

Reclassification

Existing license holders who change or reclassify their license type Need to follow procedure outlined in the License Reclassification Policy.

Invoicing Process

The CGA will email the invoice to the email address provided by the local director and will also upload the invoice in the online portal.

Collection process

Application fee

Once an application has been submitted an invoice for the application fee will be issued. Processing of the application will not commence until the fee has been paid in full.

Application Approved, License not yet Granted.

Once an application has been approved invoice(s) will be issued for the Annual Fees as outlined above. Licenses are not formally granted, nor Green Seal(s) issued, until the invoices have been paid in full.
